



ADMISSION TO THE GRADUATE PROGRAM IN RELIGIOUS STUDIES AT UFJF FOR FOREIGN CANDIDATES – CONTINUOUS FLOW

The Graduate Program in Religious Studies at UFJF, makes public the Call for continuous flow and established the norms of the selection process to fill vacancies for foreign candidates with permanent residence abroad for the Master and Doctorate courses, according to the requirements of the Program's Regulation.

1 – ON THE CANDIDATES

1.1 Foreign citizens will be able to participate in the selection process. Foreigner are considered all non-Brazilian citizens who live, permanently, abroad.

§1º. Candidates with Brazilian nationality who live in a foreign country for more than five years are equated to international students.

§2º. Candidates with foreign nationality who reside in Brazil will also be equated with foreign students.

2. NUMBER OF VACANCIES: The vacancies will be defined by the collegiate considering the analysis of the requests.

3. APPLICATION TO THE SELECTION PROCESS:

3.1. The applications to the selection process of foreign candidates to the Master and Doctorate courses of the Religious Studies Graduate Program at UFJF must be done through e-mail sent to the e-mail of the Secretary of the Religious Studies Graduate Program, together with the documents described in item 3.5.

3.2. The candidates must present certificate of proficiency in Portuguese (up to one year after registering), besides that of a second language among the ones requested by the Program (English, German, French or Italian) in the terms of the Portaria/SEI number 1046, from September 16 2020, which regulates the registration of international students at UFJF: <https://www.ufjf.br/prograd/wp-content/uploads/sites/21/2020/09/Potaria- conjunta1.pdf>

3.2.1. Alternatively, the proficiency in foreign languages can be attested through approval in Text Understanding Exam in foreign language, offered by PPCIR or any other Program of the Federal Graduate Studies system in Brazil or by presenting a diploma/certificate of proficiency acknowledged by language school submitted to the evaluation of PPCIR's collegiate.

3.2.2. Candidates who do not have Portuguese as native language will have, in case of approval, one year, counting after their registration in the course, to present the certificate of proficiency in Portuguese.

3.3. The Religious Studies Graduate Program is not responsible for application requests not received due to technical reasons, failures in communication, jam in liens of communication, as well as other factors that preclude the transference of data.



3.4 In case of approval, electronic copies of documents, together with a declaration of authenticity signed by the candidate approved, must be presented to the Secretary of the Graduate Program in the deadline indicated for the confirmation of the entrance in the course, when, then, they will be sent for institutional academic registration.

3.5. At the moment of application, digitalized versions must be presented in one of the five languages accepted by the Program, of the following documents:

3.5.1. Memorial with maximum of 3 (three) pages, containing appreciation of academic and professional career, expectations in relation to the Master of Doctorate course and time availability;

3.5.2. Research Project (Master: maximum of 12 pages; Doctorate: maximum of 20 pages);

3.5.3. Curriculum (according the ORCID models);

3.5.4. All the documents requested by the DRI resolution (Available at: <https://www.ufjf.br/prograd/wp-content/uploads/sites/21/2020/09/Potaria-conjunta-1.pdf>);

3.5.5. Identification page of the passport, followed by a valid visa, and document with the name of the candidate's parents;

3.6. Candidates will not be able to participate in any part of the selections process if there is any pending related to the documents for application.

4. ENTRANCE AND STARTING OF THE COURSE

4.1. The request to enter the Program can be done at any time. However, the student will start in the beginning of each academic semester, in attention to the calendar of the Graduate Programs at UFJF.

5. REGISTRATION: Documents in Portuguese, Spanish, English, Italian or French will be accepted according to the Portaria/SEI nº 1046, of September 16 de 2020, which regulates the registration of international students at UFJF (Available at: <https://www.ufjf.br/prograd/wpcontent/uploads/sites/21/2020/09/Potaria-conjunta-1.pdf>)

6. FINAL PROVISIONS

6.1. PPCIR/UFJF does not guarantee the grant of scholarships. The availability of scholarships depends on the Financing Agencies and will be distributed according to the criteria established by them and by PPCUR/UFJF's Scholarship Committee.

6.2. The application in the process implies the full acceptance of all the terms of this Call.

6.3. What is not foreseen in the Call follows the Regulation of the Stricto Sensu Courses of the Graduate Programs Dean's Office and the General Regulation of the Federal University of Juiz de Fora.
