



POSTGRADUATE PROGRAM IN HISTORY CALL FOR MASTER'S AND DOCTORATE CANDIDATES – 2025

The Postgraduate Program in History at the Federal University of Juiz de Fora – Area of Study: *History, Culture, and Power*; Lines of research: 1. *Art History, Heritage, Culture, and Sociabilities*, 2. *Global History, Microhistory, and Epistemic Dialogues* and 3. *Politics, Culture, and Uses of the Past*; Concept 6.0 / CAPES – releases a public call for applications and the selection process rules for the 2025 Master's and Doctorate courses.

A. OPEN POSITIONS:

- 1. The Postgraduate Program in History will offer the following positions based on the corresponding lines of research:
 - I. Art History, Heritage, Culture, and Sociabilities Master's: up to 8 positions Doctorate: up to 5 positions
 - II. Global History, Microhistory, and Epistemic Dialogues Master's: up to 8 positions Doctorate: up to 5 positions
 - III. Politics, Culture, and Uses of the Past Master's: up to 8 positions Doctorate: up to 5 positions
- 2. As established by Resolution No. 67/2021-CONSU and Ordinance/SEI No. 311/2022-PROPP, the Postgraduate Program in History reserves positions for the following groups:
 - I. Black people
 - II. Traditional peoples and communities
 - III. Trans people (transgender, transsexual, and *travestis*)
 - IV. People with disabilities (PwD)
 - V. Refugees, refugee claimants, and humanitarian immigrants.

A.1. ABOUT RESERVED POSITIONS:

- 1. Information about reserved positions:
 - I. Applications from people of the aforementioned groups must be requested exclusively by the candidates;
 - II. Regardless of their condition, the candidate is not obliged to enroll as part of one of the aforementioned groups;





- III. To be considered for the reserved positions, the candidate must apply voluntarily by filling out and signing the self-declaration form based on the templates provided in the Annexes;
- IV. The approval process for reserved position applications will only begin after the definitive final results are announced, after the corresponding phase of appeals;
- V. The procedures for the hetero-identification boards (*bancas de heteroidentificação*) and special commissions will be defined by the relevant bodies of the Federal University of Juiz de Fora (*Universidade Federal de Juiz de Fora*, UFJF);
- VI. In compliance with Brazilian law, the percentage of reserved positions allocated to quotas for the Postgraduate Program in History is 50%. Therefore, in this selection process, there are 12 reserved positions for the Master's Course and 08 reserved positions for the Doctorate Course;
- VII. The selection process for reserved positions must comply with the following regulations:
 - a. Regardless of whether they opt for reserved positions or not, all candidates must undergo the same stages of the selection process; once any appeals have been resolved at the end of the process, a final score will be assigned based on the relevant ranking scope of the Program;
 - b. All approved candidates who had not opted for the reserved positions will be listed in descending order based on their final score, and candidates with a fail score will be excluded from other stages of the process;
 - c. The positions will then be filled in descending order of final score, depending on the candidate's option for reserved or general positions;
- VIII. If the reserved positions are not filled, they will be open for general competition and filled based on the ranking;
- IX. Candidates who applied for a specific reserved position can now change their application at any stage.
- 2. Candidates approved from each reserved position group must provide the following documents:
 - I. Black people: Black candidates [Black and Brown]: Besides providing the selfdeclaration, Black candidates must undergo the hetero-identification procedure in compliance with Normative Ordinance No. 4 of April 6, 2018, of the Ministry of Planning, Budget, and Management/Secretariat of People Management and Resolution Verification Committee of UFJF.
 - II. Traditional peoples and communities: Must provide a document issued by a relevant social entity proving they are part of one of the groups encompassed by decree 6,040/2007.
 - III. Trans people (transgender, transsexual, and *travestis*): If available, they will need to provide a medical report of the gender reassignment surgery and/or a legal decision regarding their name change. If possible, they may present other documents (e.g., a document proving the name change request) that confirm that they are a trans candidate. If they do not have this documentation, they must attend an interview with





a committee named by the Postgraduate and Research Sector Council (*Conselho Setorial de Pós-Graduação e Pesquisa*, CSPP).

- IV. People with disabilities: Must provide a report that proves their disability. This document (medical or psychological report or other) must be written in legible handwriting, issued in the last twelve months from the date of application in the Program, and provide information on the type and degree or level of disability, with explicit reference to the corresponding code in the International Classification of Diseases (ICD), the candidate's full name, a stamp indicating the name and registration number of the professional in the relevant council (Regional Council of Medicine [Conselho Regional de Medicina, CRM], Regional Council of Psychology [Conselho Regional de Psicologia, CRP], etc.), and the professional's signature. People with disabilities will be considered those encompassed by Article 2 of Law No. 13,146/2015 and in the categories detailed in Article 4 of Decree No. 3,298/1999, with the changes introduced by Decree No. 5,296/2004, in § 1 of the 1st Article of Law No. 12,764, of December 27, 2012 (Autism Spectrum Disorder) and those under Summary No. 377 of the Superior Court of Justice (Supremo Tribunal de Justica, STJ), observing the provisions of the Convention on the Rights of Persons with Disabilities and its Optional Protocol, ratified by Decree No. 6,949, of August 25, 2009.
- V. Refugees, refugee claimants, and humanitarian immigrants: Must provide (Individual Taxpayer Registration; National Foreigner's Registration Card; Foreigner's Identity Card), a Declaration issued by the National Committee for Refugees (*Comitê Nacional para os Refugiados*, Conare) recognizing their refugee status, a Refugee Request Protocol, or a permanent or temporary humanitarian visa issued by the National Council of Immigration (*Conselho Nacional de Imigração*).

Single paragraph: According to Decree 6,040 of February 7, 2007, which establishes the National Policy for the Sustainable Development of Traditional Peoples and Communities, traditional peoples and communities are defined as culturally differentiated groups that recognize themselves as such, have their forms of social organization, occupy and use territories and natural resources for their cultural, social, religious, ancestral, and economic sustainment by using knowledge, innovations, and practices generated and transmitted by tradition (Decree 6,040, art. 3, \S 1).

VI. Sending the relevant documents to apply for a reserved position is considered part of the formal act of pre-application request, which is to be performed by the candidate approved in the UFJF selection process.

B. APPLICATIONS:

- 1. Target audience: holders of a higher education degree accredited and recognized by the Ministry of Education.
- 2. Period: August 19 to September 20, 2024.





- 3. Applications must be sent exclusively through the Integrated Academic Management System (*Sistema Integrado de Gestão Acadêmica*, SIGAX); applications sent by mail or after the deadline will not be accepted.
- 4. To apply for the selection process, the candidate must do the following:
 - MASTER: Access <u>https://sigax.ufjf.br/publico/posstricto/edital/936</u> and complete the online registration form;
 - DOCTORATE: Access <u>https://sigax.ufjf.br/publico/posstricto/edital/937</u> and complete the online registration form;
 - Send the necessary documents in PDF format via SIGAX in compliance with the following guidelines:
 - File 1: Updated complete Lattes resume (titled as follows: CurrículoLattes_FULLNAME);
 - File 2: Master's Thesis or Dissertation Project linked to one of the Program's Lines of Research, in compliance with the standards presented in this Call (titled as follows: Projeto_Name of the line_FULLNAME);
 - File 3: FOR DOCTORATE CANDIDATES ONLY Academic Memorial in compliance with the rules defined in this Call (titled as follows: Memorial_FULLNAME);
 - The Academic Memorial is a personal document with a report, analysis, and evaluation of meaningful events regarding only the applicant's academic, professional, and intellectual path. This document should highlight each stage of the candidate's experience and be written in the first-person singular so that the candidate can present their trajectory and motivations that led them to seek a Doctorate at the Postgraduate Program in History (PPGH) at UFJF. The document must have a maximum of 5 pages.

- File 4: Proof of proficiency in one or more foreign languages, if applicable (titled as follows: ComprovanteSuficiência_FULLNAME), as established below:

- 4.1 For English:
 - a. TOEFL IBT (Internet-Based Testing): minimum score of 72, valid for two years; MyBest scores of TOEFL iBT will be accepted.
 - b. TOEFL ITP (Institutional Testing Program): minimum score of 543, valid for two years;
 - c. IELTS (International English Language Test): minimum score of 6, valid for two years, with a minimum score of 5 at each band (listening, reading, writing, and speaking);
 - d. Cambridge Certificate: minimum level B2, no expiry date; or
 - e. DET (Duolingo English Test): minimum score 105, valid for two years

4.2 For French:





- a. TCF (Test de Connaissance du Français) TP: minimum level B2 in the mandatory tests (global results), valid for two years;
- b. TCF CAPES: level B2, valid for two years;
- c. DALF (Diplôme Approfondi de Langue Française): minimum level C1, no expiry date; or
- d. DELF (Diplôme d'Études en Langue Française): minimum level B2, no expiry date.
- 4.3 For Spanish:
 - a. DELE (Diplomas de Español como Lengua Extranjera), issued by Instituto Cervates: minimum level B2, no expiration date; or
 - b. SIELE (Servicio Internacional de Evaluación de la Lengua Española): : minimum level B2, valid for 5 years. The candidate must take the full exam and achieve B2 in each band (Listening comprehension; Reading comprehension; Writing expression and interaction; Oral expression and interaction).
- 4.4 For Italian:
 - a. IIC (Istituto Italiano di Cultura): Lato Sensu test, minimum level B2, valid for one year;
 - b. CELI (Certificato di Conoscenza della Lingua Italiana): minimum level CELI 3, no expiry date; or
 - c. CILS (Certificazione di Italiano come Lingua Straniera): minimum level CILS due B2, no expiration date, the Lato Sensu test from the Istituto Italiano di Cultura will be accepted: minimum level B2, valid for one year.

All proof of a level B2 proficiency based on the Common European Framework of Reference for Languages (CEFR) or proof of proficiency in one or more foreign languages previously obtained in a Postgraduate Program recognized by CAPES will be accepted.

- 5 The respective self-declaration form must be completed in full and signed for candidates applying for reserved positions, as applicable. (Annexes III, IV, V, VI, and VII). The document must be sent via SIGAX as file 5 (titled as follows: AutoDeclaração_FULLNAME);
- 6 The documentation must be included when completing the application on SIGAX;
- 7 The Postgraduate Program in History is not responsible for applications not received due to technical and/or computational aspects, communication failures, or high traffic on communication lines that hinder data transfer. The same applies to arguments that may arise during online interviews;
- 8 The information provided will be the sole responsibility of the candidates, and the Postgraduate Program in History reserves itself the right to exclude them from the selection process if the mandatory documentation is presented with partial, incorrect, or inconsistent





data at any stage or if they exceed what was requested or do not follow the specified deadlines, as well as if the information is later found to be untrue;

- 9 After the Examining Board checks the data and confirms that the documents have been sent as instructed in this Call, the list of valid applicants will be published on the Program website: <u>http://www.ufjf.br/ppghistoria</u>.
- 10 Applying for the selection process implies that the candidate is aware and accepts all the provisions of this Call and, as such, may not claim ignorance of them;

W. STEPS OF THE SELECTION PROCESS:

1. Master's

I. Assessment of the Dissertation Project: This is performed without the candidate's presence and may lead to elimination from the process. The result is published in the format of a list of application numbers by line of research, attributing the ratings of *apto* (eligible) or *não-apto* (not eligible) at <u>http://www.ufjf.br/ppghistoria</u>

II. Written Test: affects the ranking and may lead to elimination from the process. The candidates rated *eligible* in the Dissertation Project must be present on **November 8, 2024**, from 8 AM to 12 PM, in Auditorium 3 of the Institute of Human Sciences at UFJF. The results will be published in the format of a list of application numbers by line of research, with the candidate scores, including those disqualified, at <u>http://www.ufjf.br/ppghistoria</u>

III. Written Test for Foreign Language Proficiency: may lead to elimination from the process. The candidates rated *eligible* in the Dissertation Project and the Written Test must be present on **November 18, 2024,** from 8 AM to 10 AM, in Auditorium 3 of the Institute of Human Sciences at UFJF. The results will be published in the format of a list of application numbers by line of research, with the candidate scores, including those disqualified, at <u>http://www.ufjf.br/ppghistoria</u>

IV. Interview: affects the ranking and may lead to elimination from the process. Based on the analysis of the candidate's academic trajectory, with emphasis on the Dissertation Project and the Written Test, with mandatory presence of candidates who have passed the written tests (content test and foreign language proficiency test), held in the building of the Institute of Human Sciences, in the Postgraduate Program in History, between **November 28 and 29**, **2024**. Candidates who do not reside in Juiz de Fora have the option of attending the interview using a videoconferencing platform with the institution's official account that will be made available to candidates by the Board upon completion of Annex VII at the time of application (requests made after application will not be considered). The results will be published in a list of application numbers by line of research, with the candidate scores, including those disqualified, at http://www.ufjf.br/ppghistoria.

The Portuguese language proficiency of international students will be verified during this step.





2. Doctorate

- 1. Assessment of the Thesis Project: affects the ranking and may lead to elimination from the process. Performed without the presence of the candidate. The results will be published in a list of application numbers by line of research, with the candidate scores, including those disqualified, at http://www.ufjf.br/ppghistoria.
- Written Test for Foreign Language Proficiency: may lead to elimination from the process. The candidates approved in the Thesis Project Assessment must be present on November 18, 2024, at 8 AM, with each test taking 2 hours in Auditorium 3 of the Institute of Human Sciences at UFJF. The results will be published in a list of application numbers by line of research, with the candidate scores, including those disqualified, at http://www.ufjf.br/ppghistoria.
- 3. Interview: affects the ranking and may lead to elimination from the process. Based on the analysis of the candidate's academic trajectory, with emphasis on the Thesis Project and the Academic Memorial, with the mandatory presence of candidates who have passed the foreign language proficiency tests held in the building of the Institute of Human Sciences in the Postgraduate Program in History, between November 28 and 29, 2024. Candidates who do not reside in Juiz de Fora have the option of attending the interview using a videoconferencing platform with the institution's official account that will be made available to candidates by the Board upon completion of Annex VII at the time of application (requests made after application will not be considered). The results will be published in a list of application numbers, by line of research and in ranking order, with the candidate scores, including those disqualified, at http://www.ufjf.br/ppghistoria.

The Portuguese language proficiency of international students will be verified during this step.

D. PROJECTS

D.1 DISSERTATION PROJECT

- 1. The candidate must write the Dissertation Project;
- The Dissertation Project must contain the following: 1. cover page with the title, abstract, up to 5 keywords, and line of research chosen by the candidate; 2. specification of the theme; 3. problematization; 4. justification; 5. objectives; 6. methodology and sources; 7. execution schedule; 8. bibliographical references; 9. annexes;
- **Note:** Annexes are strictly intended to complement the project with images, documents, tables, etc., that the candidate considers essential. Projects that contain additional text in annexes regarding any of the 8 previous items will be disqualified.





- 3. The Dissertation Project must not exceed 12 pages, including "bibliographic references" and excluding the cover page and annexes (which cannot exceed 3 pages). Projects with a higher number of pages will be automatically disqualified;
- 4. Formatting: A4 sheet; 2 cm margins; Times New Roman font 12; line spacing 1.5;
- 5. The Dissertation Project must not include the name of the candidate or any indication of authorship in the file or throughout the text; otherwise, it will be automatically disqualified;
- 6. Dissertation Projects rated *apto* (eligible) will be approved;
- Dissertation Project evaluation criteria adopted by the Examining Board: 1. Academic relevance; 2. adequacy regarding the line of research; 3. theoretical consistency; 4. methodological precision; 5. viability; 6. feasibility; 7. supervisor availability.
- 8. Projects not complying with the structure indicated in this Call will be disqualified.

D.2 THESIS PROJECT:

- 1. The candidate must write the Thesis Project;
- 2. The Thesis Project must be written in Portuguese;
- The Thesis Project must contain the following: 1. cover page with the title, abstract, up to 5 keywords, and line of research chosen by the candidate; 2. specification of the theme; 3. problematization; 4. justification; 5. objectives; 6. methodology and sources; 7. execution schedule; 8. bibliographical references; 9. annexes;
 Note: Annexes are strictly intended to complement the project with images, documents, tables, etc., that the candidate considers essential. Projects that contain additional text in annexes regarding any of the 8 previous items will be disqualified.
- 4. The Thesis Project must not exceed 20 pages, including "bibliographic references" and excluding the cover page and annexes (which cannot exceed 5 pages). Projects with a higher number of pages will be automatically disqualified;
- 5. Formatting: A4 sheet; 2 cm margins; Times New Roman font 12; line spacing 1.5;
- 6. The Thesis Project must not include the name of the candidate or any indication of authorship in the file or throughout the text; otherwise, it will be automatically disqualified;
- 7. Thesis Projects that get a score equal to or greater than 70.0 (seventy) out of a total of 100.0 (one hundred) points will be approved;





- 8. Thesis Project evaluation criteria adopted by the Examining Board: 1. academic relevance; 2. adequacy regarding the line of research; 3. theoretical consistency; 4. methodological precision; 5. viability; 6. feasibility; 7. supervisor availability.
- 9. Projects not complying with the structure indicated in this Call will be disqualified.

E. WRITTEN TEST (MASTER'S ONLY):

- 1. Consulting the bibliography, personal notes, and/or using electronic devices will not be permitted during the written test;
- 2. The test will consist of 1 (one) question by the Evaluating Board based on the following reference works:

- 3. The candidates' name must not be included in the Written Test answer key, under penalty of being disqualified;
- 4. For identification purposes when taking the test, candidates will be required to present an original photo ID document;
- 5. The test must be written in Portuguese.
- 6. Candidates that get a score equal to or greater than 70.0 (seventy) out of a total of 100.0 (one hundred) points will pass;
- 7. Correction criteria for the Written Test: 1. content mastery; 2. clarity; 3. coherence; 4. objectivity; 5. comprehension of the questions;
- 8. The final score for the Written Test will be the simple arithmetic average of the scores awarded by the members of the Examining Board (Weight 01);
- 9. The Written Test affects the ranking and may lead to elimination from the process.

F. WRITTEN FOREIGN LANGUAGE PROFICIENCY TEST:

- 1. The Written Foreign Language Proficiency Test will last 02 (two) hours each;
- 2. The use of dictionaries will be permitted during the test (they can be bilingual);
- 3. Borrowing dictionaries from other candidates and/or using any electronic devices during the test will not be permitted;





- 4. The candidates' name must not be included in the Written Foreign Language Proficiency Test answer key under penalty of disqualification;
- 5. For identification purposes when taking the test, candidates will be required to present an original photo ID document;
- 6. Candidates that get a score equal to or greater than 70.0 (seventy) out of a total of 100.0 (one hundred) points will pass;
- 7. The French test is mandatory for English-speaking foreign candidates;
- 8. The English test is mandatory for French-speaking candidates;
- 9. Doctorate candidates must pass the tests or provide proof of proficiency in English and one other language from the following options: French, Italian, or Spanish;
- 10. After document analysis, the Program will inform which cases will be exempt from the Written Foreign Language Proficiency Test based on the proof of sufficiency sent, as defined in items 4.1, 4.2, 4.3, and 4.4 of this Call;
- 11. The Written Test of Proficiency in a Foreign Language may lead to elimination from the process. Candidates that get a score equal to or greater than 70.0 (seventy) out of a total of 100.0 (one hundred) points will pass;

G. INTERVIEW

- 7. The final score for the interview will be the simple arithmetic average of the scores awarded by the members of the Examining Board (Weight 01);
- 8. The Interview affects the ranking and may lead to elimination from the process.
- 9. The same categories apply to candidates whose requests for remote participation have been approved by the evaluation board. The Postgraduate Program in History is not responsible for failed applications due to technical and/or computational aspects, communication failures, or high traffic on communication lines that hinder the online interviews.

Annex I - LINES OF RESEARCH

Art History, Heritage, Culture, and Sociabilities

The research is related to the historical, theoretical, methodological, and practical processes related to the history of art and culture, including visual culture and the history of images in all their variations, amplitudes, and complexities. It focuses on studying artistic objects and collections, investigating their interdisciplinary relationships.

This research is also interested in theoretical reflections about movies and audiovisual in dialogue with other arts and fields of knowledge from a historical and political perspective. It seeks to critically reflect on the aesthetics of moving images alongside aspects such as authors, genre, film analysis, and narrative construction.

Another aspect of this research is related to the discussion on the history of women and gender as a fertile ground for investigation to analyze female protagonism in the political culture in Brazilian society and dissents against gender roles between the 19th and 20th centuries. Intersectionality – materialized in the triad of gender, race, and class – is essential to this discussion.

The investigations include reflections, practices, and processes focused on heritage and how to preserve it, given its characteristic polysemy. Research that, both locally and internationally, discusses the concepts of historical, cultural, natural, material, and immaterial heritage while also addressing topics, trajectories, policies, safeguarding experiences, mobilization strategies, reparation, heritage education, management, safeguarding and elaboration, performance, and adoption of decolonial perspectives.

Global History, Microhistory, and Epistemic Dialogues

From a polycentric perspective, the research adopts the Program's tradition with microhistory methodology and its relationship with global history to study history, culture, and power from the perspective of social history. Microhistory uses generative analyses that consider the diversity of people and groups and how they understand the world and manage relationships. In this model, relevant questions are identified with an unpredictable myriad of answers that, in turn, can generate other broad questions that had been previously neglected. Concepts such as translocality, connected histories, comparative history, strategies, and networks of individuals and groups translate the epistemological complexity of the research. The notion of situated knowledge





as a condition for universality and knowledge of local research as a strategy for thinking about global, colonial, post-colonial, and transnational contexts are at the core of the investigations.

This research line focuses on research about Atlantic history from the 15th to the 21st centuries, with an emphasis on Brazil and America, in the history of pre-colonial, colonial, and post-colonial Africa and various topics of global history, covering the world of work, family history, history and inequalities, political elites, political cultures, coloniality of power, slavery, race and racism, history and law, ancient regime cultures, modernity and colonialism, slavery and capitalism, rights and citizenship, ethnicities, "cultures, religions, and religiosities", diasporas and Black cultures, gender and politics, intersectionalities, borders, post-colonial societies, history and anthropology, Indigenous peoples, history and reparation policies, culture and nature, traditional communities, cities and peripheries, migrations, oral history, public history and epistemic dialogues, history of memory, and historiography.

Politics, Culture, and Uses of the Past

The Politics, Culture, and Uses of the Past line of research belongs to the field of Political History and Social History, which emerged from the epistemological remodeling and the expansion of research objects from the advent of new understandings about the meanings of the political and the social, in addition to the use of new sources and research methodologies. The expansion and redefinition of Political History and Social History enables the intersection between these and other fields of historiography to be reassessed.

From this perspective, this line of research seeks to reflect on the interactions between political agents, both individuals and groups, the State, various institutions, and civil society through their repertoires and political organizations and mobilizations, all as historical subjects that compose our field of analysis. The complexity of the objects involved requires this line of research to advance towards the study of political traditions and cultures concretely, their impacts on behavior and decision-making processes, the analysis of memories and political uses of the past, the investigation of capitalism and Western democracies, as well as their contexts of crisis, in line with the emergence of the extreme right, denialism, and authoritarianism, and the historical framework of reorganization of social movements, the left and the various forms of resistance and utopias. These elements make the fields of Political History and Social History ideal for interdisciplinary debates and a better understanding of complex and non-linear phenomena.





As such, this line of research seeks to bring the analyses of the classic themes of traditional Political History closer to the challenges of the History of the Present Time by promoting debates around objects and connections between different scales of time and space, with perspectives ranging from local to global, from short to long-term. All of this enables reflections about the challenges posed by new communication and information technologies, as well as digital social networks, which continually transform the notions of public space, public sphere, and public opinion, profoundly impacting social life and political participation globally.
