

# Public Call nº 01/2025 SELECTION PROCESS FOR THE MASTER'S PROGRAM IN LINGUISTICS

The Graduate Program in Linguistics<sup>1</sup> (stricto sensu) at the Federal University of Juiz de Fora (UFJF), in the exercise of its legal duties, hereby announces the public selection process for the Master's Degree in Linguistics, for the cohort beginning in the first semester of 2026.

#### 1. AVAILABLE POSITIONS:

1.1. For the 2026 selection process for the Master's Program in Linguistics, up to 16 (sixteen) positions will be offered, distributed among research lines and thematic areas within each line, as shown in the table below:

- 1.2. Fifty percent of the positions offered in each thematic area will be reserved for applicants who belong to one of the following groups: black people, traditional peoples and communities, trans individuals (transgender, transsexual, and travesti persons), persons with disabilities, refugees, asylum seekers, and humanitarian immigrants (in accordance with Resolution No. 67/2021 CONSU and SEI Ordinance No. 311, of March 7, 2022).
- 1.2.1. The percentage above shall be applied to each of the thematic areas defined in the table in item 1.1 and will be rounded up in the case of a non-integer result.
- 1.2.2. Registration for the aforementioned groups must be expressly requested by the applicant.
- 1.2.3. Regardless of their status, no candidate is required to apply under any of the reserved quota categories.
- 1.2.4. Participation in the selection process under the affirmative action quotas is voluntary and must be indicated through the completion and signing of the self-declaration form, according to the models available in Annex I.
- 1.2.5. The validation process for inclusion in the quota group will only begin after the publication of final results and any appeals.
- 1.2.6. Procedures carried out by hetero-identification panels and special committees will follow the calendar established in SEI Ordinance No. 975, of July 5, 2022, and will be regulated by specific normative instruments.
- 1.2.7. Applicants who register under a specific quota group will not be allowed to alter this registration at any stage of the selection process.
- 1.3. The Graduate Program in Linguistics reserves the right not to fill all available positions. There is no obligation to issue a separate call for the filling of vacant positions. Moreover, candidates approved as surplus may not be reallocated to thematic areas other than those to which they applied.

### 2. CANDIDATE REQUIREMENTS:

2.1. Applicants for the 2026 selection process for the Master's Program in Linguistics must hold an undergraduate degree recognized by the Brazilian Ministry of Education (MEC), or, in the case of foreign applicants, by the competent authority in their country of origin. Alternatively, applicants may present an official document proving that they are expected to complete their undergraduate

studies before the start of the graduate program. The undergraduate degree must be completed before enrollment in the graduate program is finalized.

#### 3. APPLICATIONS:

- 3.1. Applications will be open from 5:00 p.m. on August 11, 2025, until 4:59 p.m. on September 29, 2025, and must be submitted free of charge, exclusively online via a specific application form made available through the UFJF institutional system "Siga X", accessible at http://www.ufjf.br/ppglinguistica.
- 3.2. All fields of the application form must be completed as instructed. Failure to comply with these instructions may result in the application being denied.
- 3.3. Required documents for application:
- 3.3.1. Duly completed electronic application form;
- 3.3.2. For candidates applying under affirmative action quotas: a signed self-declaration form stating the relevant group of belonging, following one of the templates provided in Annex I;
- 3.3.3. Undergraduate diploma, or an official document proving the degree has been obtained, or, for those in the final phase of their undergraduate studies, an official statement from the home institution indicating the expected graduation date (which must be prior to enrollment in the graduate program);
- 3.3.4. For candidates requesting exemption from the English language proficiency exam: proof of proficiency in English by one of the following exams, meeting the minimum scores and within the validity period when applicable: TOEFL ITP (460 points); TOEFL iBT (57 points); IELTS (4.0 points); Cambridge (FCE or higher); TOEIC (550 points). Foreign applicants whose first language is English may be exempted from the exam. Alternatively, proof of passing a graduate-level English proficiency exam in another stricto sensu selection process; or an undergraduate degree in English or Portuguese-English Language and Literature, whether in the form of a teaching degree or a bachelor's degree are also accepted as proof of proficiency in English;
- 3.3.5. For foreign applicants whose first language is not Portuguese, as well as for Brazilian Deaf applicants requesting exemption from the Portuguese proficiency exam: proof of proficiency in Portuguese through exams such as Celpe-Bras or equivalent (minimum level: Upper Intermediate). Alternatively, proof of passing a Portuguese language exam in another graduate-level selection process; or undergraduate degree in Portuguese Language and Literature, whether in the form of a teaching degree or a bachelor's degree, are also accepted as proof of proficiency in Portuguese;
- 3.3.6. For all applicants, identification document (ID card, passport, driver's license, work card, or professional council card); for Brazilian or naturalized applicants: CPF (individual taxpayer number), voter registration document and proof of compliance with electoral obligations (available at <a href="http://www.tse.jus.br/eleitor/servicos/certidoes/certidao-de-quitacao-eleitoral">http://www.tse.jus.br/eleitor/servicos/certidoes/certidao-de-quitacao-eleitoral</a>), as well as proof of compliance with military service obligations, for male applicants;

- 3.3.7. Statement indicating the intended Research Line and Thematic Area, as well as the ranking of preferred supervisors within the chosen area (see Annex II);
- 3.3.8. All required documents must be attached to the electronic application form in PDF format.
- 3.4. The list of accepted and rejected applications will be published by 5:00 p.m. on October 6, 2025, on the program's website (www.ufif.br/ppglinguistica).
- *3.4.1*. Appeals against application rejection may be submitted until 5:00 p.m. on October 8, 2025, via electronic form on the Siga X system, accessible at <a href="https://www.ufif.br/ppglinguistica">www.ufif.br/ppglinguistica</a>.
- 3.4.2. The result of the appeal will be published by 5:00 p.m. on October 10, 2025, on the program's website (<a href="https://www.ufjf.br/ppglinguistica">www.ufjf.br/ppglinguistica</a>).
- 3.5. If the documents submitted as proof of English and/or Portuguese proficiency (items 3.3.4 and 3.3.5) are not accepted, the candidates will be required to take the language proficiency exams as provided for in this call.
- 4. STAGES AND TENTATIVE DATES FOR THE SELECTION PROCESS:
- 4.1. The selection process for the Master's Program in Linguistics (stricto sensu) at UFJF for the year 2026 will consist of two stages:

Stage 1: Language proficiency tests in:

- reading and writing in Portuguese (for Deaf applicants only); or reading and writing in Portuguese (for foreign applicants whose first language is not Portuguese);
- reading in English (for all applicants).

Stage 2: Test on specific knowledge in the field of Linguistics.

- 4.1.1. Since all courses in the graduate program are taught in Portuguese and/or English, and course syllabi include references in English, proficiency in both Portuguese and English is mandatory for non-Lusophone and/or non-Anglophone foreign applicants, as well as for Deaf applicants. These requirements cannot be fulfilled by proficiency in other languages.
- 4.2. The exams for stages 1 and 2 will be held in person, on the UFJF campus, in the Faculty of Letters (Faculdade de Letras), from October 13 to 14, 2025, at locations to be announced on the program's website (<a href="www.ufjf.br/ppglinguistica">www.ufjf.br/ppglinguistica</a>), according to the following preliminary calendar:

- 4.2.1. Applicants will be exempt from the Portuguese proficiency exam if they submit, at the time of application, documentation proving proficiency in Portuguese through Celpe-Bras (Upper Intermediate level or higher), a graduate selection exam, or a degree in Portuguese Language and Literature (licentiate or bachelor's).
- 4.2.2. Applicants will be exempt from the English proficiency exam if they submit, at the time of application, valid documentation demonstrating the required scores on standardized tests (see 3.3.4), or have completed a degree in English Language and Literature (licentiate or bachelor's), or if English is their first language.
- 4.2.3. Only Deaf and/or foreign applicants who are approved in or exempt from the Portuguese proficiency exam will have their English proficiency test graded. Failing this requirement will result in elimination from the process.
- 4.2.4. Only applicants who pass or are exempt from the English proficiency exam will have their specific knowledge tests graded. Failing this requirement will also result in elimination.
- 4.3. The first stage (language proficiency) is eliminatory. Applicants may use printed dictionaries, but sharing dictionaries is not allowed.
- 4.3.1. In the first stage, deaf applicants must take, in Portuguese, a written Portuguese proficiency exam and are entitled to take the English reading exam in Brazilian Sign Language (Libras), which will be video recorded. Alternatively, they may provide proof of proficiency as per 3.3.4. (except if English is their L1).
- 4.3.2. Foreign applicants whose first language is not Portuguese must take the Portuguese written proficiency test. They must also take the English reading exam or present the documentation listed in 3.3.4 (unless English is their L1).
- 4.3.3. In the first stage, all applicants must take the English reading exam, except those who prove exemption according to 4.2.2 or whose first language is English.
- 4.3.4. Interpreters will provide Libras translations of the English proficiency questions for Deaf applicants.
- 4.3.5. The duration of each exam in Stage 1 is up to 3 hours.
- 4.3.6. To pass Stage 1, the applicant must score at least 60 out of 100 points on the applicable exam(s).
- 4.3.7. Evaluation criteria for language proficiency exams include: (a) ability to read academic texts; (b) clarity of reasoning and expression; (c) logical structure, synthesis, and conclusion skills; (d) formal written language skills.
- 4.3.8. No form of assistance is permitted during the exam, whether remote or in person, except as specified in this call.

- 4.3.9. The results of the specific written Portuguese language proficiency tests for deaf candidates and foreign candidates will be announced by 5 p.m. on October 15, 2025, on the program's website (www.ufjf.br/ppglinguistica).
- 4.3.10. Appeals regarding the specific written Portuguese language proficiency tests for deaf candidates and foreign candidates may be made until 5 p.m. on October 17, 2025, using the electronic form available on the institutional system Siga X, accessible through the website www.ufjf.br/ppglinguistica.
- 4.3.11. The results of the appeal for specific written Portuguese language proficiency tests for deaf candidates and foreign candidates will be announced by 5 p.m. on October 20, 2025, on the program's website (www.ufjf.br/ppglinguistica).
- *4.3.12.* The results of the English reading proficiency test will be announced by 5 p.m. on October 20, 2025, on the program's website (www.ufjf.br/ppglinguistica).
- *4.3.13.* Appeals regarding the English reading proficiency test may be submitted until 5:00 p.m. on October 22, 2025, using the form available on the institutional system Siga X, accessible through the website www.ufjf.br/ppglinguistica.
- *4.3.14.* The result of the appeal for the English language reading proficiency test will be announced by 5 p.m. on October 23, 2025, on the program's website (www.ufif.br/ppglinguistica).
- 4.4. The second stage, which is eliminatory in nature, will consist of a test of specific knowledge in Linguistics. Only candidates who have passed and/or been exempted from the immediately preceding stage will participate in this stage.
- 4.4.1. In the second stage, deaf candidates will be guaranteed the opportunity to take the specific knowledge test in Linguistics in Brazilian Sign Language. To this end, candidates will be assisted by an interpreter affiliated with UFJF.
- 4.4.2. The specific knowledge test in the area of Linguistics will consist of two questions: one common to all candidates and one specific to each thematic area, according to the candidate's choice at the time of registration.
- 4.4.3. Both the question common to all candidates and the questions specific to each area will have as initial and non-exhaustive bibliographic references the texts listed in Annex III.
- 4.4.4. No reference materials will be allowed during the Linguistics knowledge test.
- 4.4.5. To pass the second stage, candidates must obtain a score of 60 (sixty) points or higher out of a total of 100 (one hundred) points.
- 4.4.6. The following criteria are relevant for the evaluation of specific knowledge in the field of Linguistics, according to the scoring system set out in Annex IV: (a) knowledge of theoretical categories and basic concepts of Linguistics; (b) ability to understand and synthesize academic texts; (c) ability to analyze linguistic data; and (e) mastery of prestigious urban norms.

- 4.4.7. The results of the second stage will be announced by 5 p.m. on October 29, 2025, on the program's website (www.ufjf.br/ppglinguistica).
- 4.4.8. Appeals for the second stage may be made until 5 p.m. on October 31, 2025, using the electronic form available on the institutional system Siga X, accessible through the website www.ufjf.br/ppglinguistica.
- 4.4.9. The result of the second stage appeal will be announced by 5 p.m. on November 3, 2025, on the program's website (www.ufjf.br/ppglinguistica).
- 4.5. The scores obtained by the candidates in each stage of the selection process, as well as the preliminary results of the selection process, still pending approval by the Collegiate Body, will be announced by 5 p.m. on November 4, 2025, on the program's website (www.ufjf.br/ppglinguistica).
- 4.6. Appeals regarding the scores obtained and preliminary results may be submitted until 5 p.m. on November 6, 2025, using the electronic form available on the institutional system Siga X, accessible via the website www.ufjf.br/ppglinguistica.
- 4.7. The result of the appeal against the scores obtained and the preliminary results of the selection process will be announced by 5 p.m. on November 7, 2025, on the program's website (www.ufjf.br/ppglinguistica).
- 4.8. All preliminarily approved quota candidates and surplus candidates up to three times the number of places allocated to quotas will be summoned to the panels and/or committees for hetero-identification and/or document verification applicable to each of the groups defined in Resolution No. 67/2021 CONSU.
- 4.8.1. Quota candidates will be asked to complete the following procedures and/or submit the following supporting documents:
- 4.8.1.1. Black candidates (black and brown): will undergo the heteroidentification procedure, complementary to the self-declaration, in accordance with the provisions of Normative Ordinance No. 4, of April 6, 2018, of the Ministry of Planning, Development, and Management/Secretariat of Personnel Management and Resolution of the UFJF Verification Commission.
- 4.8.1.2. Traditional Peoples and Communities: Presentation of a document issued by a representative society proving membership in one of the groups provided for in Decree 6.040/2007.
- 4.8.1.3. Transgender individuals (transgender, transsexual, and transvestites): If available, they must submit a medical report of sex reassignment surgery and/or a legal decision to change their name. If possible, they may submit other documents (e.g., a document proving a request for name change) that attest to the fact that they are a transgender candidate. If they do not have this documentation, they will participate in an interview with a committee appointed by the CSPP for this purpose.

- 4.8.1.4. People with Disabilities: They will need to submit proof of disability in the form of a report. This document (medical, psychological, etc.) must be written in legible handwriting, have been issued within the last twelve months from the date of enrollment in the Program, and provide information on the type and degree or level of disability, with express reference to the corresponding International Classification of Diseases (ICD) code, citing the candidate's full name, stamp indicating the name, registration number with the professional council (CRM, CRP, etc.), and the signature of the professional responsible for its issuance. Persons with disabilities shall be those who fall under Art. 2 of Law No. 13,146/2015 and the categories listed in Art. 4 of Decree No. 3,298/1999, with the amendments introduced by Decree No. 5,296/2004, in § 1 of Art. 1 of Law No. 12,764, of December 27, 2012 (Autism Spectrum Disorder) and those covered by the statement in Precedent No. 377 of the Superior Court of Justice (STJ), in accordance with the provisions of the Convention on the Rights of Persons with Disabilities and its Optional Protocol, ratified by Decree No. 6,949, of August 25, 2009.
- 4.8.1.5. Refugees, asylum seekers, and humanitarian immigrants: must present (Individual Taxpayer Registration Number; National Foreigners' Card; Foreign Identity Card) or Declaration issued by CONARE (certificate of recognition of refugee status), or Refugee Application Protocol, or permanent or temporary humanitarian visa issued by the National Immigration Council.
- 4.8.2. The examination boards and committees will be scheduled by the Dean of Graduate Studies and Research (PROPP).
- 4.8.3. The preliminary results of the examination boards and committees referred to in item 4.8 will be disclosed directly to the candidates by the examination boards and committees responsible for the evaluation.
- 4.8.4. Appeals against the preliminary results of the boards and committees referred to in item 4.8 may be made in accordance with the instructions provided by the responsible department.
- 4.8.5. The results of appeals against the preliminary results of the boards and committees referred to in item 4.8 will be disclosed directly to candidates by the responsible department.
- 4.8.6. Candidates approved through any quota system at any Federal Educational Institution, at the undergraduate or graduate level, will have their approval automatically ratified and will be exempt from participating in the panel, provided they apply for enrollment in the exact group of their current submission to the Graduate Course at UFJF and present a document proving their approval by the respective quota system.
- 4.8.7. For candidates who have graduated from UFJF undergraduate courses and already have academic records related to the quota groups established at this institution (Black, Brown, and Indigenous Groups or PcD Group), it will not be necessary to send supporting documents.
- 4.8.8. Candidates approved through a quota system at a private or community higher education institution must submit supporting documentation to the committee responsible and designated by the CSPP for this purpose.

4.9. The final result approved by the Graduate Program in Linguistics Collegiate Body will be announced after the conclusion of the procedures of the boards and committees for hetero-identification and/or document verification, on the program's website (www.ufjf.br/ppglinguistica).

#### 6. FINAL PROVISIONS:

- 6.1. The examination boards for all stages will be formed by the faculty of the Graduate Program in Linguistics at UFJF.
- 6.2. All appeals will be judged by the Selection Process Committee. The examination boards responsible for preparing and correcting the tests may be consulted if necessary.
- 6.2.1. Candidates are guaranteed the right to view the content of all tests taken and the respective score sheets. Such requests may be made using the appeal form itself when the appeal period for each stage opens.
- 6.2.2. The Selection Committee has 24 hours to make the requested content available to the candidate. It is recommended that the request for review be submitted as soon as the appeal period opens, so that the candidate has sufficient time to prepare and submit their appeal within the 48-hour deadline.
- 6.3. Written tests will be anonymized for blind correction by the examining board.
- 6.4. Persons with disabilities (PCD) must indicate their special needs on the registration form so that accessibility and other conditions that enable their equal participation in the selection process can be provided.
- 6.5. On the days and times scheduled for the tests, each candidate must go to the UFJF Faculty of Letters to take the respective test.

- 6.6. Candidates are advised to arrive at the designated test locations at least 30 minutes in advance, carrying photo identification and a blue or black pen.
- 6.7. Entry into the exam rooms will not be permitted 15 minutes after the start of the exam.
- 6.8. No candidate will be allowed to leave the exam room before 60 minutes have elapsed since the start of each exam.
- 6.9. For each grade, as well as in the calculation of averages, values will be considered up to the first decimal place (inclusive), with rounding applied if there is a second decimal place, as in the examples: 82.46 and 61.42 officially become 82.5 and 61.4.
- 6.10. In the event of a tie between candidates, preference will be given to the older candidate.
- 6.11. The results of each stage of the selection process, as well as the final result, will be disclosed by means of a nominal list, ordered by ranking, with the scores of each candidate, including those who have been disqualified.
- 6.12. Test results will not be provided by telephone or email.
- 6.13. The final ranking of candidates will be in descending order according to the score obtained in the Linguistics test, as well as each candidate's choice to be included or not in the quota group, within the limit of vacancies in this call.
- 6.14. The call for approved and unranked applicants for immediate admission (surplus) will only occur after the enrollment of ranked applicants or after formal withdrawal of a ranked candidate for a position for which there is a surplus applicant.
- 6.15. The enrollment of the selected applicant will take place during a period to be announced by the Program Secretariat.
- 6.16. For the enrollment of the applicant approved in this call, the following documents will be required, without which the candidate cannot be admitted as a student in the program: undergraduate diploma; undergraduate transcript; identification document (identity card, passport, driver's license, work card, or professional license); birth or marriage certificate; CPF. In addition to the documents listed, approved Brazilian candidates must present their voter registration card; document proving that the candidate is in good standing with their electoral obligations, accessible at: http://www.tse.jus.br/eleitor/servicos/certidoes/certidao-de-quitacao-eleitoral, as well as a document proving that the person is in good standing with their military obligations, in the case of male applicants. For foreign candidates who are approved, the documents defined by the UFJF International Relations Office at the time of enrollment are also required.
- 6.16.1. Applicants who hold an undergraduate degree issued by a recognized institution will be given the opportunity to present proof of completion of the undergraduate course at the time of enrollment, and the duly registered higher education diploma must be presented no later than 60 days before the scheduled date for the defense of the dissertation or thesis.

- 6.16.2. In accordance with the terms of Article 14, V, of the General Regulations for Stricto Sensu Graduate Programs, foreign candidates, in addition to presenting a valid identity document, must present a temporary or permanent visa authorizing them to study in Brazil for enrollment.
- 6.17. The minimum period for completion of the master's program, including the dissertation, cannot be less than 12 or more than 24 months, except in exceptional cases provided for in Article 33, § 1, of the General Regulations for Stricto Sensu Graduate Programs at UFJF.
- 6.18. The candidate's registration implies knowledge and tacit acceptance of the rules and conditions contained in this Notice, in relation to which they cannot claim ignorance.
